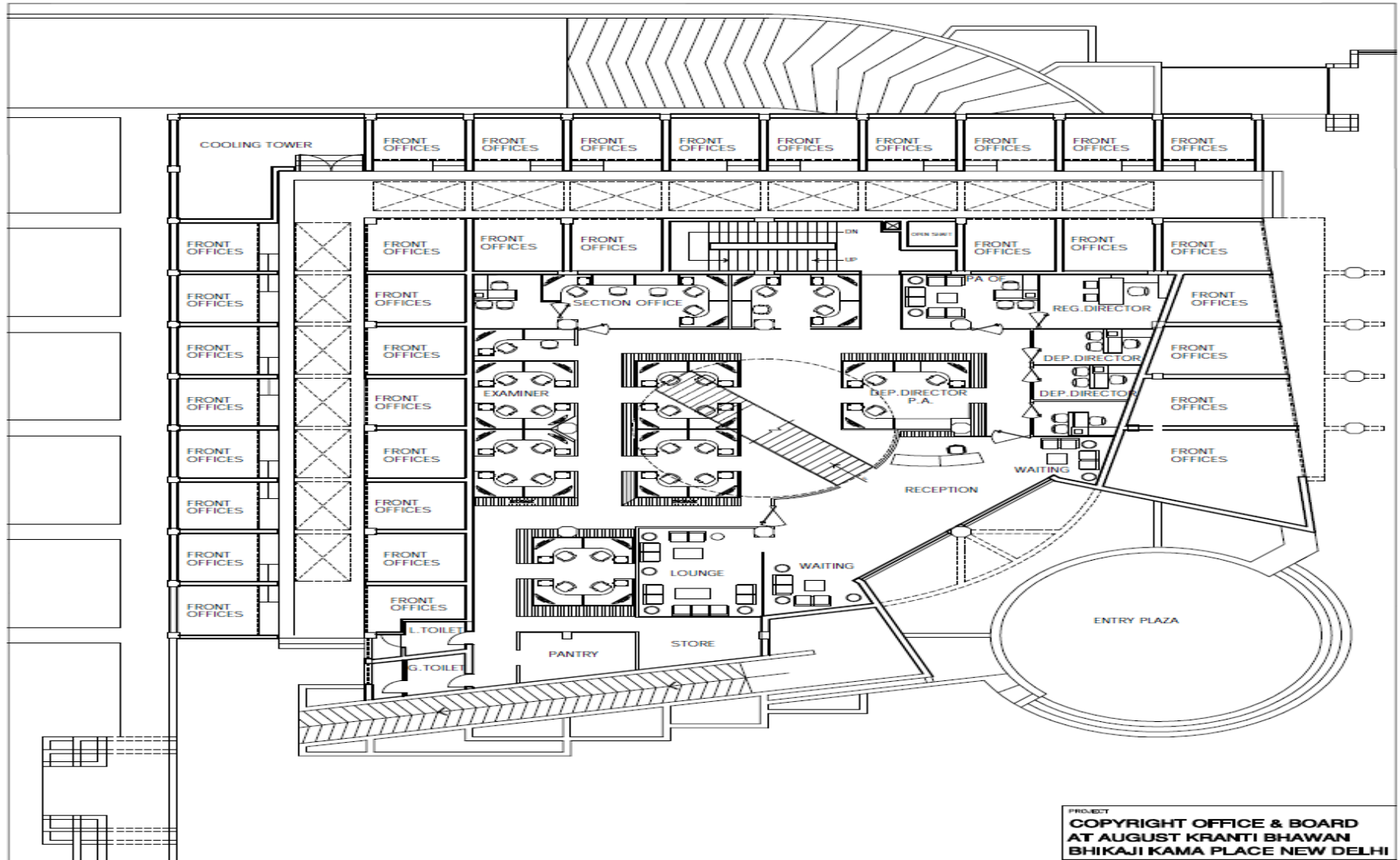

EMD submitted in the form of Demand Draft is acceptable from both Nationalized and Scheduled bank. Whereas for Bank guarantee, the same is acceptable only from Nationalized bank.
2.	Instruction to Bidders Clause-8	4	Is NSIC registered suppliers are exempted from submission of EMD and bid fees.	All SSI units having valid registration certificate only with NSIC for items mentioned in Annexure-A is exempted from submission of EMD and Bid document fees but they have to submit the requisite valid registration and exemption certificate issued by NSIC. If they fail to submit the required certificates, the bid submitted by them will be summarily rejected.
3.	Instruction to Bidders Clause-10	4-5	Is any authorization is required for the official signing & submitting the bid.	Each page of the Technical Bid (PART-I) & Financial Bid (PART-II) must be sealed and signed by the authorized signatory of the bidder.
