

9. Reply, if any, be filed within four weeks. Rejoinder thereto, if any, within four weeks, thereafter.

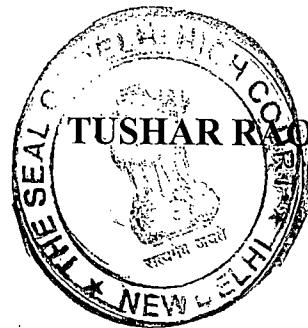

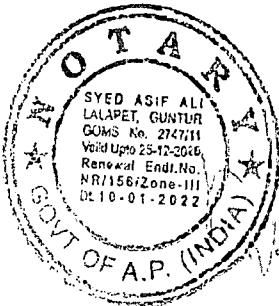

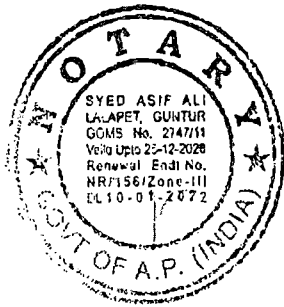
